

Poudre School District Board Policies

JLIE - STUDENT VEHICLE USE AND PARKING

When parking lots are provided on campus, all student-driven vehicles shall be parked in such lots. No vehicles may be driven on school grounds except in designated parking areas.

Student-driven vehicles shall remain parked while students are scheduled to be in class. No loitering in parked cars or on school parking lots shall be permitted during the school day.

The privilege of bringing a student-operated motor vehicle onto school premises is based upon the condition of consent by the student driver to allow a search of the vehicle when there is reasonable suspicion the search will yield evidence of contraband.

Refusal by a student, parent/guardian, or vehicle owner to allow search access to a motor vehicle on school premises when requested shall be cause for termination without further hearing of the privilege of bringing any vehicle onto school premises by said individual.

Each school is authorized to engage in routine patrolling of student parking lots, visual inspection of student automobiles, and the use of dogs trained to alert at the scent of drugs, explosives and other contraband.

Principals may adopt additional parking and driving regulations as necessary for the proper operation of their schools and programs.

JIH – AUTOMOBILE SEARCHES

Each school retains the authority to patrol its student parking lots, and all vehicles parked in student lots are subject to sniffs by dogs trained to alert at the scent of drugs, explosives and other contraband. In addition, the interiors and trunks of all vehicles parked by students at school may be searched upon reasonable suspicion that they contain items or substances which it is illegal for students to possess and/or items or substances which District policy or regulations prohibit from being on school property. Failure to allow the search of a vehicle's interior or trunk under these circumstances will result in the student's automatic loss of the privilege of parking at school for at least the remainder of the academic year.

The following rules will be enforced to assist in a safe and orderly environment for Fossil Ridge High School.

All students and staff parked on school property must display a valid and current parking hang tag (Permit).

PSD, Police, Fire, Delivery service, and Visitor vehicles are excluded from displaying a parking hang tag and receiving school tickets.

Parking hang tag may be obtained by contacting a Campus Security Officer or appointed school official.

All fines must be paid and up to date before receiving a hang tag.

Falsification on parking application will result in driving and parking privileges onto Campus being revoked.

Only 1 parking hang tag is allowed per student unless lost or stolen and a fee will be charged to replace lost or stolen tags.

Hang tags may not be transferred from one person to another person.

Campus Security or appointed school official must be notified if parking hang tag is lost or stolen and a new tag must be purchased.

Campus Security or appointed school official must be notified if there is a change of vehicles.

Parking hang tag must be returned if student has lost parking privileges, been expelled, or withdrawn from school.

Moving another persons vehicle to cause a violation will result in driving and parking privileges suspended or revoked.

Offensive writing, signage, or gang affiliation items may not be displayed in or on vehicles on PSD property.

Anyone found to be involved in a hit and run will have driving and parking privileges onto Campus revoked

FRHS tickets may be issued upon any violation or action that may be a safety concern.

Tickets may be issued by School Resource Officer resulting in fines, loss of points on drivers license or court appearance.

Vehicles may be booted after 2 tickets for any offense and arrangements must be made with appointed school official for release.

A fine may be accessed when a vehicle is booted and all fines must be paid to remove the boot from your vehicle.

Vehicles may be booted if fines are not paid with-in 1 month.

Vehicles larger than current parking spaces or pulling trailers onto property must have administrator approval.

Disrespect to other drivers or insubordination to staff will result in driving and parking privileges onto Campus being revoked and disciplinary action.

Driving and parking privileges onto Poudre School District property may be temporarily or permanently suspended for any violation at any time.

Continued defiance of School rules or District policy may result in a vehicle being booted or towed and the owner/driver paying the costs associated with that boot or tow.
