

Violations that may be ticketed and/or booted

\$10 Fine

- Valid parking hanger not displayed
- Parking hanger # not visible or readable
- Parked taking 2 spaces or across lines
- Parked in striped area, no parking /tow zone
- Parked on the curb or sidewalk
- Parked on the grass
- Parked on snow piles
- Appearing to exceed the speed limit
- Failing to stop where posted or marked
- Stopped or parked in traffic lane

\$40 Fine

- Student parked in the Staff lot or space
- Student parked in the Visitor's space
- Parked in the Bus Lane
- Parked in the Fire Lane/Red Curb
- Parked in Maintenance Parking

\$50 Fine

- Display of lost, stolen, borrowed, copied parking hanger
- Careless driving
- Reckless Driving (also includes loss of parking/driving privileges on campus for a MINIMUM of 4 WEEKS)

City of Fort Collins Ticket

- Parked in a Handicapped space without proper permit
- Tickets may be issued by School Resource Officer resulting in fines or loss of points on driver license.

Please contact a Campus Security Officer or Dean to resolve any ticket, driving, or parking issue.

To appeal tickets, contact Campus Security within 2 DAYS of receiving citation. Failure to do so will be considered intent to pay.

You MUST follow the appeals process in order to contest a PSD citation

2nd Contact - Dean of Students

Expectations

Providing a SAFE ENVIRONMENT is a large part of Rocky Mountain High School's mission statement. Rocky accommodates hundreds of student drivers and staff members every day of the school year, and it is our goal to make sure ALL drivers at RMHS exemplify the "Lobo Way" by driving safely and responsibly every day!

Careless/Reckless Driving Policy

Careless Driving (\$50 Fine)

Careless driving shall be defined as any person driving in a careless and imprudent manner, without due regard for width, curves, corners, and traffic of roads and parking areas.

Examples of careless driving include but are not limited to the following:

- Driving over curbs or landscaped areas
- Rear-ending or backing into another vehicle
- Driving on snow piles

Reckless Driving (\$50+ Fine)

Reckless driving shall be defined as any person who is driving in such a manner as to indicate a willful disregard for the safety of persons or property.

Examples of reckless driving include but are not limited to the following:

- Burnouts & Fishtailing
- Failure to stop at an occupied crosswalk
- Driving the wrong direction on roadway

A reckless driving citation will ALSO include the loss of parking privileges on campus for a MINIMUM OF 4 WEEKS.

Careless and reckless driving citations may be issued based on a number of different driving scenarios. The above examples encompass only the most common infractions. Rocky Mountain High School reserves the right to issue careless or reckless driving citations as deemed appropriate by RMHS Administration & campus security.

Please refer to the PSD Student Rights & Code of Conduct online for Board Policies related to driving and parking on PSD property.

The following rules will be enforced to assist in a safe and orderly environment for Rocky Mountain High School.

- All students and staff parked on school property must display a valid and current parking permit.
- Parking hanger may be obtained by contacting a Campus Security Officer or the Dean's Office.
- All fines must be paid and up to date before receiving a parking hanger.
- Falsification on parking application will result in driving and parking privileges onto campus being revoked.
- Only one parking hanger is allowed per student. A fee will be charged to replace lost or stolen hangers.
- Parking hangers may not be transferred from one person to another person.
- Campus Security or the Dean's Office must be notified if parking hanger is lost or stolen and a new permit be purchased.
- Campus Security or the Dean's Office must be notified if there is a change of vehicles.
- Parking hanger must be returned if student has lost parking privileges, been expelled, or withdrawn from school.
- Moving another persons vehicle to cause a violation will result in driving and parking privileges suspended or revoked.

**Speed limit at RMHS
is 10 MPH**

- Offensive writing, signage, or gang affiliation items may not be displayed in or on vehicles on PSD property.
- Students may not loiter in vehicles during class hours.
- PSD tickets may be issued upon any violation or action that may be a safety concern.
- Tickets may be issued by School Resource Officer resulting in fines or loss of points on driver license.
- Vehicles larger than current parking spaces or pulling trailers onto property must have administrator approval.
- Disrespect to other drivers or insubordination to staff will result in driving and parking privileges onto campus being revoked and disciplinary action.
- Driving and parking privileges onto Poudre School District property may be temporarily or permanently suspended for any violation at any time.

What Happens if I don't pay the citation?

- Fines not paid within 30 days from date of issue may result in the following:
 - *Parent/Student Contact
 - *Booted Vehicle
 - *Loss of Parking Privileges
 - *Meeting with Dean's Office
 - *Transcripts & Diploma Withheld
- Parents/guardians of students with excessive fines will be notified prior to receiving a boot.
- A fine will be assessed when a vehicle is booted and all fines must be paid to remove the boot from your vehicle.
